# PCC Participation in Kickapoo Trail Ride

John introduced Mary Ellen Wuellner and Lisa Sprinkle of the Champaign County Forest Preserve District administration who asked for Prairie Cycle Club help in organizing a first ride, in what is hoped to become an annual event, to promote bicycling on the Kickapoo Trail between the Middle Fork Forest Preserve district and Kickapoo State Park. The ride would be a benefit for the trail--charge fee for entry ~\$20-25 and a family rate. The proposed date for the ride is mid September, with Middle Fork Forest Preserve or Homer Lake serving as the staging point for the ride. Don't want the ride to compete with the Bike the Bridges Ride (10/5) or the Wabash County Ride or Capital City Ride in Springfield. CCFPD staff would be involved with the ride if it doesn't occur on the Labor Day Holiday.

Discussion moved to initial ideas for the ride: a short family ride, with some attention to non ride events within Middle Fork Forest Preserve; a medium length ride; and a long ride along the Kickapoo Trail to Kickapoo State Park, and possibly beyond. Other activities would include alternative activity at Middle Fork for families that want to participate but don't want to do the ride--perhaps a bike rodeo. CCFPD could also do a naturalist's talk after a short ride. Safe Rides people could run the bike rodeo.

Publicity for the ride could include LIB calendar, Mike Bentley and NG article from Jodie Heckel.

Discussion also included details about setting up the ride: the ride will need rest stops along the route. PCC knows how to set up SAG stops, we've used Casey's as rest stops. We could also contact people in Vermilion County to assist with Sag Stops. Would need SAG vehicles on the road--a car dealership loaner has been used by PCC. ride insurance from PCC--Pay fee for non-members for insurance rider. through LIB-American Specialty Insurance.

Gravel was a problem for visibility. More signs needed on roads with gravel
Use white paint for road signs next year; white for directions and orange for gravel
warnings.

Use more paint and make the marks bigger. put marks in right wheel track.

More pavement marking throughout the course and also for coming into and going out
of town

Mark every 2 miles. Some people felt the marking was sketchy--not enough.

Every change of direction had three markers.

For straight through roads no marks were necessary..
